शुद्धिपत्र / CORRIGENDUM

विषय :- निविदा सं० 2298/ 5-एन दिनांक 05-11-2018 के लिये शुद्धि पत्र (Corrigendum).

- निविदा में संशोधन किये गये वो निम्नानुसार है को उपरोक्तानुसार ही निविदा में पढा जाये :-
- SI. 1 (Scope of the work & eligibility criteria for drivers)**
 - All the vehicles are to be provided with qualified Drivers. The Drivers should be Of Indian nationality, male with more than 18 years of age and minimum 8th Pass with sound health and vision.
 - The drivers of the vehicle must have valid commercial driving license (photo copies/Originals must be submitted at the time of inspection).
 - SI. 2 TYPE OF VEHICLES, THEIR DETAILS, PERIOD OF CONTRACT AND AREA OF WORK**

Row-6 Approximate period of hiring of vehicles--04-05 months(period can be reduced or increased)
 - SI. 3 ELIGIBILITY CRITERIA(FOR THE AGENCY):**
 - Bidder having good track record, manpower capacity and relevant experience as said above are only eligible to apply (under taking to be attached).
 - SI. 6 (Other terms and conditions)**
 - Necessary permit for driving the vehicles in area of field duty for at least one year from the date of commencement.
 - Valid comprehensive insurance cover policy at least one year from the date of commencement
 - SI. 8 (Performance security)**
 - The performance Security should be furnished by successful bidder for an amount of 10% of the Contract Value with validity of fourteen months or 60 days beyond the date of completion of all contractual obligations whichever is later. The successful Agency shall furnish the performance security in the form of Bank Guarantee from a nationalized bank in favour of "E&AO, Gujarat Daman & Diu G.D.C." and payable at Gandhinagar protecting the interests of the Government in all respects. The proceeds of the Performance Security shall be payable to the Survey of India as compensation for any loss/penalties/liquidated damages resulting from the service provider's failure to honour its obligations under the contract. Performance security should be deposited within 14 days of the issue of letter of intent/award of contract.
