Sir,

I have the honour to invite Department's kind attention to the letters cited under references above. In this regard it is intimated that the Dehradun District has been notified as Red Zone vide D.O Letter No.Z-21020/16/2020-PH dated 15-04-2020 (Copy Attached), issued by the Secretary to the Govt of India, Department of Health and Family welfare, Ministry of Health & Family Welfare, and the Nagar Nigam Area of Dehradun City is under Hot Spot and Containment Area. The Surveyor General's Office and Other Offices of Survey of India at Dehradun station are situated within the Nagar Nigam Area of Dehradun City.

Accordingly, in pursuance of the Para 2 of MHA, Govt. of India's order and Guidelines cited under ref.(i) and Para 3 of District Magistrate Dehradun order cited under ref.(ii) the Surveyor General's Office and other Offices of Survey of India at Dehradun Station have not been allowed to open during the lockdown period from 20-04-2020 to 03-05-2020. However the essential services like Accounts/Budget/Pays/Wages etc. works of the Department at Dehradun station will be continue to operate as being done till now. All officers will be working from home as eoffice facility has been provided to all the officers and concerned section officers also. This office has also taken VC facility from NIC for survey of India which is different from Zoom VC offered by NeGD.
