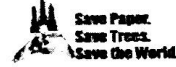

THE STATUS OF THE POINTS AS ON 29-10-2018, RAISED BY THE REPRESENTATIVES OF GROUP 'B' GAZEETED OFFICER'S ASSOCIATION IN THE MEEING HELD ON 12-09-2018 UNDER THE CHAIRMANSHIP OF SECRETARY, DST.

(1) Upgradation of pay scale-

The recommendation of Surveyor General of India for up gradation of pay scales of Officers Surveyors were submitted to DST vide this office letter No. J-2159/612-Group 'B' dt. 09-08-2017.

Further, the DST has referred this matter to Department of Expenditure for reconsideration with clarification provided on 30-07-2018 decision is awaited.

(2) Amendment of RRs-

The amendments of RRs of different cadres, Group 'A', 'B' and 'C' posts in Survey of India are under process / processed. The RRs in r/o the post of Officer Surveyor and Surveyor have already been submitted to DoPT for concurrence/approval. In respect of Group 'A' posts the draft RRs have been sent to DoPT.

(3) Seniority list of Officer Surveyors-

The task of revision of Seniority list of Officer Surveyors from 1995 to till date is in advance stage of completion and being scrutinized and examined. It will be submitted to DST by 15 November, 2018 subject to outcome of court cases related to Seniority of Officer Surveyors.

(4) Promotion to the post of Superintending Surveyors from Officer Surveyors by diverting the vacancies of SS meant for promotion from DSS to SS (Civil/Defence Stream).

In this regard it is informed that the regular promotion order of 02 adhoc Superintending Surveyor to Superintending Surveyor and 03 Officer Surveyor to Superintending Surveyor have been issued vide this office's letter No.C-5750/853-SS dt. 23-10-2018. Further, it is intimated that the proposal of diversion of vacancies (in the grade of Superintending Surveyor) from the quota of DSS (Defence Stream) and DSS (Civil Stream) to the grade of Officer Surveyor have already been sent to DST.

(5) Cadre Restructuring of Group 'A', 'B' and 'C'.

In this regard a Note on Cadre Restructuring of Group 'B' and 'C' cadres of Survey of India, particulars of meeting held with the staff associations regarding Cadre Restructuring proposal and a table showing existing no. of posts, no. of posts proposed in 2011-15, no. of posts proposed in 2018 in respect of Group 'B' & 'C' have already been uploaded in Departmental website of Survey of India.

(6) Transfer/posting orders-

The new placement committee for transfer posting of Officer Surveyors have been constituted vide this office's letter No.E1-423/1466-Placement Committee (Coll.-1) dated 03-10-2018. The list of Officer Surveyors now eligible for transfer will be uploaded in departmental website in Survey of India by 31-10-2018 for seeking options for place of postings.

(7) **Renewal of Recognition of Association for five years as per DoPT's guidelines.**

In this regard the documents submitted by General Secretary Group 'B' Gazetted Officers Association were duly checked with the official records and sent to DST vide this office's letter No.J-1552/2158 – Recognition dated 23-04-2018.

In continuation of above, an explanation was called on from General Secretary Group 'B' Gazetted Officers Association for violation of Para 6(d) of DoPT's notification No. 2/10/80-JCA(Vol. IV) dt. 05-11-1993. The explanation received from the General Secretary Group 'B' Gazetted Officers Association has been submitted to DST vide this office letter No.J-3568-B/2158-Recognition dated 28-09-2018, for further necessary action.

(8) **Rectification of APAR of President and waiving off penalty given to General Secretary of Association by the Surveyor General.**

In this regard, these point can not be sorted out in the Association meeting because these issues are personal in nature and as per para 6(b) of DoPT's notification no. 2/10/80-JCA (Vol. IV) dt. 05-11-1993. Raising personal issue is violation of the rules.

(9) **Schedule for meeting of Surveyor General of India with the representatives of Group 'B' Gazetted Officers Association -**

In this regard, a letter will be issued very shortly for the schedule of meeting for third quarter (October, 2018 to December, 2018) with Surveyor General of India of Local Headquarters Office Bearers of Group 'B' Gazetted Officers Association. It is also intimated that the schedule of annual meeting of Surveyor General of India with the representative of Central Headquarters of Group 'B' Gazetted Officers Association will be intimated after the third quarter meeting.
