In this file, we are dealing with the proposal of SoI dated 01 May, 2018 relating to amendments to be carried out in the Recruitment Rules, 1989 for the 01 post of Stores Officer, Survey of India.

2. The RRs, 1989 has become due for making amendments for amendments due to revision in the Pay Scales on the recommendation of 7<sup>th</sup> Central Pay Commission in Col. No. 04 (**Annexure-D**), formation of committees for promotion/DR in Col. No.12 (F/A) to the post of Stores Officer, SoI are to be amended.

3. The above proposed amendments in the RRs, 1989 for the post of Stores Officer, SoI are to be carried out as per the guidelines issued by DoP&T vide their OM No. 14017/2010-Estt.(RR) dated 31.12.2010.
