

#### 3. Eligibility criteria:

- (i) The bidding firm should be registered with the appropriate Govt. authorities. The copy of the Registration Certificate must be enclosed with the tender.
- (ii) The bidding firm must enclose the Registration Certificate of VAT/Tax from the appropriate authorities. While quoting please certify that you are paying your assessed Income Tax and Sales Tax regularly.
- (iii) Copy of Service Tax Registration Certificate must be attached with the bid.
- (iv) The tenderer must provide the PAN/TAN number of the firm. Copies of Income Tax Returns filed by the firm for last 02 years should be enclosed with the tender.
- (v) The bids received without the above mentioned certificates/documents will be rejected.

#### 4. Terms and Conditions:

- (i) Quotation should be submitted under sealed cover only mentioning the quotation letter No., date and item quoted for.
- (ii) All quotations should be addressed to "The Director, Kerala & Lakshadweep Geo-Spatial Data Centre, Survey of India, CGO Complex, Poonkulam, Vellayani P.O., Thiruvananthapuram 695522 and NOT BY NAME AND NOT TO ANY OTHER ADDRESS. The complete address of your firm with telephone & fax number must be mentioned on the envelope
- (iii) It is to clearly mention, whether the quoted rate is inclusive of taxes or exclusive. If the rate is exclusive of taxes, then the details and nature of the taxes and the total cost of item quoted should be specified. Tax exemption, if any, certificate to be attached along with the quotation.
- (iv) Warranty of UPS should be for minimum two years.
- (v) The quantities mentioned are approximate which may vary at the discretion of the Director, Kerala & Lakshadweep Geo-Spatial Data Centre at the time of placing supply order.
- (vi) The rate quoted should shall be mentioned by the agency both in figure and words. There should not be any erasing or overwriting whatsoever to avoid rejection of bid. The rate quoted should remain valid for a period of 60 days from the date of opening of the bids.

- (vii) The Earnest Money Deposit (EMD) of Rs. 5000/- (Rupees Five thousand only) in shape of Demand Draft drawn on any nationalized bank in favour of the "CDDO, K&L GDC, Survey of India, Thiruvananthapuram" payable at Thiruvananthapuram should be furnished with the tender. The tender received without EMD will be summarily rejected. The EMD of unsuccessful tenderers will be returned within 30 days of award of purchase order.
- (viii) Bids received after stipulated date and time due to any reason whatsoever including postal delay shall not be considered.
- (ix) The Director, K&L GDC, Survey of India, Thiruvananthapuram reserves the right to accept or reject any/all bids without assigning any reason whatsoever.
- (x) Bids with overriding conditions will be summarily rejected.
- (xi) If there is no mention of taxes etc. in the bid, the bid will be considered to be inclusive of all taxes and no extra tax will be paid in any case.
- (xii) Quotations should be strictly as per specification.
- (xiii) Please specify the approximate time required for supply after getting the supply order.
- (xiv) Consigner is responsible for safe arrival of goods at the destination. Transit insurance will not be paid separately by this Office.
