

TERMS & CONDITIONS

- Bid Security of Rs. Nil for the items listed in Annexure 'A' should be deposited along with the sealed tender in the shape of Demand Draft in favour of CDDO, Survey of India, Patna failing which tender will not be accepted. Bidder who are interested for all the items listed in Annexure 'A' should deposit Rs. Nil.
- 2. Quotation should be submitted under sealed cover for the items listed in Annexure 'A'.
- Quotation should be addressed to the Director, Bihar Geo-Spatial Data Centre, Survey of India, Patna – 800014 and can be dropped in the office tender Box.
- The envelope containing quotation must be superscripted with QUOTATION FOR PURCHASE OF UNSERVICEABLE GOVT. STORES LISTED IN ANNEXURE 'A'.
- The rate should be quoted in word, as well as in figures. No correction or over writing in the quotation will be allowed.
- 6. The tender shall remain valid for 40 days from date of tender.
- 7. If any amount is payable on account of VAT, Sale Tax GST or any other taxes pertaining to sale/transaction, the buyer shall be bound to pay such amount in addition to the quoted rate. All such taxes shall be deposited directly with concerned authority and challan to be submitted to this office by the successful bidder at the time of delivery of the condemned stores.

- 8. Bidder if so desires may be present at the time of opening quotations.
- The Director, Bihar Geo-Spatial Data Centre, Survey of India, Patna 800014 reserves the right to reject or accept any quotations without assigning any reasons thereof.
- 10. NO VARIATION IN THE BIDDING PRICE WILL BE ACCEPTED DURING THE VALIDITY PERIOD.
- 11. Only the highest offer will be accepted.
- Successful bidder will have to deposit the full amount of unserviceable store plus challan /receipt of the taxes within 48 hours of the acceptance of his/her offer.
- Items once disposed to the successful bidder shall not be taken back by SOI under any circumstances.
- 14. The successful bidder shall be required to lift all the items from the Bihar Geo-Spatial Data Centre, Survey of India, Patna – 800014 premises to his site within 5 days during working hours after payment of the bid amount.
- Tenders received after the stipulated date and time shall not be entertained in any circumstances whatsoever including postal delay, etc.
- For the final evaluation, the highest bidder shall be chosen based on the amount quoted and fulfilling tender conditions.
- 17. No assistance whatsoever shall be provided by Survey of India for lifting the items. The successful bidder shall make his own arrangements of labour and vehicles etc. for shifting the materials to his site, at his own cost.
